Usage Guideline Description

PaymentAdviceNotifications_camt.054.001.08 ([link](#))

Scope

The BankToCustomerDebitCreditNotification message is sent by the account servicer to an account owner or to a party authorised by the account owner to receive the message. It can be used to inform the account owner, or authorised party, of single or multiple debit and/or credit entries reported to the account.

Usage

The BankToCustomerDebitCreditNotification message can contain reports for more than one account. It provides information for cash management and/or reconciliation.

The BankToCustomerDebitCreditNotification message can be used to:

- report pending and booked items;
- notify one or more debit entries;
- notify one or more credit entries;
- notify a combination of debit and credit entries.

It can include underlying details of transactions that have been included in the entry.

It is possible that the receiver of the message is not the account owner, but a party entitled by the account owner to receive the account information (also known as recipient).

It does not contain balance information.

Outline

In the Collection camt.054_PaymentAdviceNotifications, the message PaymentAdviceNotifications_camt.054.001.08 is composed of a mandatory Business Application Header V02 (head.001.001.02) and a Document.

Business Application Header V02 (head.001.001.02)

The Business Application Header V02 (head.001.001.02) is composed of 15 elements.

a - Character Set

Contains the character set of the text-based elements used in the Business Message.

b - From

The sending MessagingEndpoint that has created this Business Message for the receiving MessagingEndpoint that will process this Business Message.

Note the sending MessagingEndpoint might be different from the sending address potentially

contained in the transport header (as defined in the transport layer).

c - To

The MessagingEndpoint designated by the sending MessagingEndpoint to be the recipient who will ultimately process this Business Message.

Note the receiving MessagingEndpoint might be different from the receiving address potentially contained in the transport header (as defined in the transport layer).

d - Business Message Identifier

Unambiguously identifies the Business Message to the MessagingEndpoint that has created the Business Message.

e - Message Definition Identifier

Contains the MessageIdentifier that defines the BusinessMessage.

It must contain a MessageIdentifier published on the ISO 20022 website.

example camt.001.001.03.

f - Business Service

Specifies the business service agreed between the two MessagingEndpoints under which rules this Business Message is exchanged.

To be used when there is a choice of processing services or processing service levels.

Example: E&I.

g - Market Practice

Specifies the market practice to which the message conforms. The market practices are a set of rules agreed between parties that restricts the usage of the messages in order to achieve better STP (Straight Through Processing) rates.

A market practice specification may also extend the underlying message specification by using extensions or supplementary data of this underlying message.

h - Creation Date

Date and time when this Business Message (header) was created.

i - Business Processing Date

Processing date and time indicated by the sender for the receiver of the business message.

This date may be different from the date and time provided in the CreationDate.

Usage: Market practice or bilateral agreement should specify how this element should be used.

j - Copy Duplicate

Indicates whether the message is a Copy, a Duplicate or a copy of a duplicate of a previously sent ISO 20022 Message.

k - Possible Duplicate

Flag indicating if the Business Message exchanged between the MessagingEndpoints is possibly a duplicate.

If the receiving MessagingEndpoint did not receive the original, then this Business Message

should be processed as if it were the original.

If the receiving MessagingEndpoint did receive the original, then it should perform necessary actions to avoid processing this Business Message again.

This will guarantee business idempotent behaviour.

NOTE: this is named "PossResend" in FIX - this is an application level resend not a network level retransmission.

l - Priority

Relative indication of the processing precedence of the message over a (set of) Business Messages with assigned priorities.

m - Signature

Contains the digital signature of the Business Entity authorised to sign this Business Message.

n - Related

Specifies the Business Application Header(s) of the Business Message(s) to which this Business Message relates.

Can be used when replying to a query; can also be used when canceling or amending.

o - CrossElementComplexRule : RelatedPresentWhenCopyDupl

Related MUST contain the relevant BusinessMessageHeader elements of the BusinessMessage to which this BusinessMessage relates.

If CopyDuplicate is present, then Related MUST be present.

Document - Bank To Customer Debit Credit Notification V08 (camt.054.001.08)

The Document - Bank To Customer Debit Credit Notification V08 (camt.054.001.08) is composed of 5 elements.

a - Group Header

Common information for the message.

b - Notification

Notifies debit and credit entries for the account.

c - Supplementary Data

Additional information that cannot be captured in the structured elements and/or any other specific block.

d - CrossElementSimpleRule : MessageOrNotificationPaginationRule

MessagePagination may be present or NotificationPagination may be present, but not both.

e - Textual : SupplementaryDataRule

The SupplementaryData building block at message level must not be used to provide additional information about a transaction. The SupplementaryData element at transaction level should be used for that purpose.

1 Introduction

1.1 Introduction to Bankline Direct

Bankline Direct provides a transactional gateway between NatWest and those customers who require the facility to make payments and receive account information reports and notifications. The service supports a varied array of industry and NatWest formats to enable simple integration into customers' own systems.

The Bankline Direct service is scalable and flexible to meet the need of customers who wish to make single payments transactions or multi-payment files. An extensive number of different account information reports and payment advice notifications are available, along with reconciliation and activity reporting. All reports are published at a frequency that suits the needs of the customer.

All data exchanged between the customer and the Bankline Direct service is secure, adhering to industry security standards.

2 Camt.054.001.08 – Bank to Customer Debit Credit Notification

2.1 Purpose of camt.054

NatWest uses the camt.054 message format for Bank to Customer Debit Credit Notifications. It is used to inform the account owner, or authorized party, of single or multiple debits and/or credit entries reported to the account. A single camt.054 can contain notifications for one account only. It can include underlying details of transactions that have been included in the entry. It does not contain balance information.

This document describes the NatWest implementation of the ISO20022 camt.054.001.08 XML message for debit and credit notifications.

2.2 Use of camt.054

The camt.054 Debit Credit Notifications are only available across the following file based communications channels:

- SWIFTNet FileAct
- sFTP
- Connect Direct Secure+

Please refer to the Bankline Direct Channel Build Guidelines for setup requirements for communication channels.

2.3 Frequency of Generation

Bankline Direct Debit Credit Notifications will be generated for the accounts registered for Payment Advice Notifications service. A notification per account is generated when a Debit Credit is posted on the account and delivered with chosen preferences via chosen communication channel. Based on the chosen Notification schedule the available notification messages per account are bulked into a single file per Customer.

2.4 File Naming Convention

The file name for Debit/Credit Notifications conforms to the following convention:

Debit/Credit Notifications per account is a report which includes the notification details for a single account registered under the Customer profile.

Debit Credit Notifications per Customer is a bulk report which includes the notifications for all accounts registered under the Customer profile.

3 Camt.054 Debit Credit Notifications Format

3.1 Assumptions

1. Duplicate checking for receipt of debit/credit notification will be determined via bilateral agreement between customer and bank.
2. Bank will send Camt054 schema according to the message definition and rules, published and approved by SWIFT in Mystandards under ISO20022 MX standards.
3. Standard XML version declaration must explicitly specify that XML v1.0 is being used. The <Document> tag should specify the appropriate namespace. Example:
