Agriculture, Forestry, Fishing	Farming and hunting	This includes the production of crops, animals and animal products, hunting, trapping and related service activities.
	Forestry and logging	This includes the production of roundwood, sawnwood and wood-based panels, as well as the logging of timber.
	Fishing and aquaculture	This includes the catching, farming, and processing of fish, shellfish and other aquatic animals.
	Coal and lignite	This includes the extraction of coal and lignite.

	Paper products	This includes the manufacture of pulp, paper, and paperboard, as well as the manufacture of articles of paper and paperboard, such as corrugated paper and paperboard containers.
